Bullet Points

- Joyce’s presentation “HL7 and IHE: Paving a Common Path to Interoperability”
 - HL7 and IHE common vision – provide health information when and

- where needed
- HL7 and IHE common mission – promote interoperability by:
 - Providing standards (HL7)
 - Providing specifications, tools and services (IHE)
- HL7 and IHE have defined processes
 - IHE profile development – proven 1-year quality management cycle
 - HL7 ANSI-accredited standards process – specification development, testing and publication
- PULSE (Patient Unified Lookup System for Emergencies)
 - Real world use case for HL7 and IHE collaboration
 - Utilizes IHE profiles and HL7 FHIR standard
- Wayne’s presentation “A Joint Initiative of HL7 and IHE to Advance the Use of FHIR for Interoperability: Introduction to the Gemini Initiative”
 - Gemini operates under Statement of Understanding with oversight by a joint Steering committee; not a separate organizational entity
 - Mission: make advances in interoperability by capitalizing on advantages of FHIR and combining the strengths of both organizations
 - Objective: create new, jointly owned specifications based primarily on HL7 FHIR
 - Gemini candidate projects: 2-3 concurrent projects within 1 to 2-year timeframe
- Christopher’s presentation “Gemini Pilot Project: Imaging for Cancer Care”
 - First IHE profile was published in 1999 to address integration of radiology systems with hospital information systems; ordering à image availability
 - Current project seeking opportunities for enhanced radiology-EHR integration including:
 - Provision of decision support for ordering appropriateness
 - Viewing of patient record for relevant results
 - Provision of decision support references, guidelines, clinical pathways
 - Generation of structured reports with discrete data elements

- Presentation “**Operationalizing CRM Technology to Transform the Healthcare Experience**”
 - Presented by HIMSS Exploring Customer Relationship Management (CRM) Technology for Healthcare Task Force members
 - Why CRM in healthcare?
 - Improve operational efficiency to meet challenge of rising cost of care
 - Support sick and aging populations with multiple care providers
 - Address increased competition from mergers and partnerships
 - Task force survey (available on HIMSS.org) findings
 - Vendors are most likely user of CRM today
 - Patients are the most commonly targeted group
 - Highest priority use case is outreach and marketing
 - Task force workgroups: Use Cases, Capabilities & Requirements, Change Management
 - Capability Model
 - 78 capabilities being defined
 - Level 0 groups – Outreach & Marketing, Patient Engagement, Population Health, Customer Service, Care Management, Provider Network Management, Employee Engagement, Operations
 - CRM Change Management
 - Definition: planning, communicating and implementing CRM
 - Engagement Tool Box – Build business case, measure organizational readiness, develop CRM project charter
 - Real world examples – NYU Langone Health, Piedmont Healthcare
- Presentation “**Community Information Exchange: Addressing Social Determinants of Health through Person-Centered Care**”
- Speaker: Karis Grounds, VP of health and Community Impact, 2-1-1 San Diego
- 2-1-1
 - Information and referral service supported by United Way
 - 94.2% overall coverage nation-wide
- What we know about social determinants
 - Social influences greatly impact health
- 2-1-1 San Diego
 - San Diego background – large military population, a refugee settlement and busiest international border in the world
 - Receives 1000 – 1500 calls per day
 - Observations
 - Seeing proliferation of technology, e.g. patient portals, HIEs, Instagram
 - Heightened awareness of social determinants
 - Reduced readmissions through social navigation referrals
- Clinical Information Exchange (CIE)
 - 52 participants – formal participation agreements and business associate agreements

- Core elements: network partners, shared language, bidirectional closed loop referrals, technology platform and data integration, community care planning
- Shared clinical record with 14 social determinant domains
